

Demonetization Program of the New Design Series (NDS) of the Bangko Sentral ng Pilipinas

2015

From January 1 to December 31, 2015 – The old banknote series can still be used for daily transactions

2016

From January 1 to December 31, 2015 – The old banknote series can no longer be used for daily transactions and can only be exchanged in authorized agent banks, BSP Cash Department and any of its Regional Offices /Branches

2017

Starting January 1, 2017 – Demonetized, no more monetary value

remain as legal tender in the country

Role of RBAP

1.Exchange of currency from NDS to NGC

BSP Circular No. 863, Series 2014

"... The NDS banknotes can be exchanged within a prescribed period with the BSP or its authorized agent banks and financial institutions (universal/commercial banks, thrift banks, and rural banks) at par with the New Generation Currency (NGC) Series banknotes consisting of 20-, 50-, 100-, 200-, 500- and 1000-Piso denominations."

Role of RBAP

2. Acceptance of mutilated/doubtful notes for transmittal to BSP

BSP Circular No. 829, Series of 2014

Chapter V Section 21: "Banks shall accept from the public mutilated notes and coins for referral /transmittal to CIIO-BSP, Quezon City or any of the BSP Regional Offices/Branches for determination of redemption value. Banks may charge handling fees from clients and/or to general public relative to the handling /transporting to BSP of mutilated notes and coins. "

Role of RBAP

3. Deposit of Unfit Banknotes to the BSP

BSP Circular No. 829, Series of 2014

Chapter V Section 20: "Currency Notes and Coins considered unfit for circulation shall not be recirculated, but may be presented for exchange to or deposited with any bank."
