Subject: Amendments to the Manual of Regulations for Banks and Non-Bank Financial Institutions as of 31 March 2017

The Monetary Board, in its Resolution No. 1570 dated 14 September 2017, approved the following amendments to the Manual of Regulations for Banks (MORB) and Manual of Regulations for Non-Bank Financial Institutions (MORNBFI) as of 31 March 2017.

Section 1. The following statement is added as a footnote to Section X206.

"The new check clearing process shall be implemented on 20 January 2017. For participant banks which will not be compliant with the CICS standard on 20 January 2017, they shall execute a Letter of Commitment stating, among others, the actions that they will be taking to be compliant with the CICS standard until 21 April 2017."

Section 2. Annex A of Appendix 89 (Regulatory Relief for Banks affected by Calamities) of the MORB and Annex A of Appendix Q-67 [Regulatory Relief for Non-Bank Financial Institutions with Quasi-Banking Functions (NBQBs) affected by Calamities] of the MORNBFI are amended to add the grant of regulatory relief to covered areas affected by typhoon "Niña" pursuant to Memorandum No. M-2017-002 dated 18 January 2017 (Annexes A and A-1 of this Circular)

Section 3. The Computation Sheet for Capital Repatriation (Annex B of this Circular) referred to under Circular No. 942 dated 20 January 2017 shall be incorporated as Attachment 1 of Appendix N-8-c.

Section 4. The provisions under Memorandum No. M-2017-003 are codified in the MORNBFI P-Regulations as shown in Annex C of this Circular.
